The terms and conditions shall bind each one individually or any one or more or all of them collectively and all agreements, obligations and liabilities of the customers are joint and several. Headings in this Agreement are inserted for convenience only and shall not affect the construction of this Agreement. Any appendices attached hereto shall form an integral part of this Agreement.

The person(s) whose name(s), address(es) and other details are specified as the customer(s) in the Signature Change Request Form (hereinafter referred to as the "Customer", which expression, unless it be repugnant to the context or meaning thereof, shall include his/her/its legal heirs, successors, executors and administrators, as applicable)

1. **DEFINITIONS**

- 1.1. "Account(s)" means and includes Savings Account(s) and/or Current Account(s) and/or Deposit Account(s) opened with the Bank.
- $1.2.\ ``\textbf{Act''}\ means\ the\ International\ Financial\ Services\ Centres\ Authority\ Act,\ 2019\ (50\ of\ 2019).$
- 1.3. "Applicable Law" means any law, regulation, ordinance, rule, judgment, order, decree, bye-law, clearance, approval, directive, guideline, policy, requirement, or other governmental restriction or any similar form of decision of any Governmental Authority, or other governmental restriction or any similar form of decision of or determination by any Governmental Authority having the force of law and jurisdiction over the matter in question, whether in effect as of the date of this Applicable Law or at any time thereafter.

"Governmental Authority" means any: (a) government (central, state or otherwise) or sovereign state; (b) any governmental agency, semi-governmental or judicial or quasi-judicial or regulatory or administrative entity, department or authority, or any political subdivision thereof; or (c) international organization, agency or authority including, without limitation, any self-regulatory organization, established under any Applicable Law.
- 1.6. "IFSC" shall have the meaning assigned to the term under the Act.
- 1.7. "RBI" shall mean the Reserve Bank of India

I/We agree that the Bank is entitled to decline the Signature Change request and/or reject or cancel the request without furnishing any reason whatsoever, and also agree that the Bank may contact us and request for further information or documents for the purpose of evaluating, examination and scrutinizing our request or any or all information or details provided or furnished by us.
